Waiver of Release of Liability

In exchange for receiving permission to rent Kayaks/Paddleboards and/or instruction and related activities and/or the use of the facilities, property, services, and equipment of Ultimate Boat Lifts, I hereby RELEASE, WAIVE, DISCHARGE, AND COVENANT NOT TO SUE Ultimate Boat Lifts, Dean Glover, their officers, agents, or employees, instructors and owners of equipment and land used for Paddleboarding (hereinafter referred to as "RELEASED PARTIES") from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or to any property belonging to me, while participating in such activity, while in, on or upon the premises where the rental activities are being conducted, REGARDLESS OF WHETHER SUCH LOSS IS CAUSED BY THE NEGLIGENCE OF THE RELEASEES.

I hereby understand and agree for myself and if applicable the members of my family to this Release of Liability, Waiver of Legal Rights and Assumption of Risk and to the terms hereof as follows:

1. In this Release Agreement, the term "Related Activities" shall include all activities, transportation, events and services provided, arranged, organized, conducted, sponsored or authorized by the Released Parties and shall include but is not limited to: stand-up paddle boarding/kayaking, swimming, Stand Up Paddle Boarding Yoga and other forms of land or water-based activity; rental or use of standup paddle boards/kayaks or other equipment; demonstrations; instructional courses; loading, unloading of equipment including around motor vehicles; and other activities, events and services in any way connected with or related to Stand Up Paddleboarding/kayaking.
